Motion by Kehn, seconded by Hagman, to supplement the election budget by \$3,492.00, HAVA grant funds. With no further discussion and all voting yes, the motion carried.

Motion by White Hawk, seconded by Kehn, to approve the 2012 Homeland Security Grant, authorizing the chairman to sign. With no further discussion and all voting yes, the motion carried.

Motion by White Hawk, seconded by Hutchison, to table the Total Vote contract with the Secretary of State due to concerns about legal issues regarding the use of HAVA funds. With no further discussion and all voting yes, the motion carried and the matter tabled.

Motion by Hutchison, seconded by Hagman, to accept the General Fund Surplus Analysis dated September 30, 2012 as follows and place it on file. With no further discussion and all voting yes, the motion carried.

SHANNON COUNTY GENERAL FUND SURPLUS ANALYSIS DATE: SEPTEMBER 30, 2012

The amount of General Fund dollars that counties can retain as surplus is restricted by SDCL 7-21-18.1, which states: "The total unreserved, undesignated fund balance of the general fund may not exceed forty percent of the total amount of all general fund appropriations contained in the budget for the next fiscal year. The total unreserved, undesignated fund balance of the general fund of the county as of March thirty-first and September thirtieth shall be published in the minutes of the proceedings of the board of county commissioners and reported to the Department of Legislative Audit. The report shall be on forms prescribed by the Department of Legislative Audit."

The following analysis should be completed as of March thirty-first and September thirtieth of each year. Thereafter, the unreserved, undesignated fund balance amount should be published in the minutes of the governing board. This analysis should also be filed with the Department of Legislative Audit.

Susie Hayes, Director of Equalization, met with the Board to present two abatements for approval. Motion by Hutchison, seconded by White Hawk, to approve an abatement for The Brain Train for 2009 taxes in the amount of \$116.83, 2010 taxes in the amount of \$113.43 and 2011 taxes in the amount of \$115.59, for a total of \$345.85 on a mobile home that should have been exempt due to ownership by a tribal member and has been destroyed by a storm. With no further discussion and all voting yes, the motion carried.

Motion by Kehn, seconded by White Hawk, to approve an abatement for Kathy Pilcher for 2011 taxes in the amount of \$612.10 on a mobile home which should be exempt due to ownership by a tribal member. With no further discussion and all voting yes, the motion carried.

Motion by Hutchison, seconded by Kehn, to enter into Executive Session with Archie Hopkins for a personnel evaluation. With no further discussion and all voting yes, the motion carried and the Board went into Executive Session at 12:48 PM.
