SHANNON COUNTY MINUTES OF FEBRUARY 7, 2014

The Shannon Board of County Commissioners met in regular session on February 7, 2014. Present: Bryan Kehn, Lyla Hutchison, Wendell Yellow Bull and Sue Ganje, Auditor. Absent: Anna Diaz Takes The Shield and Eugenio White Hawk.

The Pledge of Allegiance was given and the meeting called to order at 12:15 PM. The agenda was reviewed for conflicts; none were indicated. Motion by Kehn, seconded by Hutchison, to approve the agenda as written. With no further discussion and all voting yes, the motion carried.

Motion by Kehn, seconded by Hutchison, to approve a policy to prohibit any political campaigning within 100' of the courthouse, or any other location established for early absentee voting, for the period of time that early voting is being conducted for any election administered by the Auditor's Office. With no further discussion and all voting yes, the motion carried.

The Shannon County Conservation District financial report was reviewed. Motion by Kehn, seconded by Hutchison, to accept and place on file the 2013 financial report of the Shannon County Conservation District. With no further discussion and all voting yes, the motion carried.

Motion by Hutchison, seconded by Kehn, to approve advertising for a Lakota 2014 Election Coordinator. With no further discussion and all voting yes, the motion carried.

Motion by Hutchison, seconded by Kehn, to approve the second reading of Ordinance #2014-01, establishing an on-sale liquor license for full-service restaurants. With no further discussion and all voting yes, the motion carried.

The Board took no action on the Resolution setting Fair Market Value for Liquor Licenses for full-service restaurants and referred the matter to the next agenda.

Lynx Bettelyoun, Highway Superintendent, updated the Board on activities and Eric Rounds, Butler Machinery, discussed equipment. The Board presented Bettelyoun with a certificate of their appreciation for his performance with storm clean-up efforts and the FEMA application process, along with his overall performance as Superintendent.

Motion by Hutchison, seconded by Kehn, to approve travel for Bettelyoun to attend Short Course training in Oacoma on March 18-20, 2014. With no further discussion and all voting yes, the motion carried.

A hearing on private roadwork was held at 12:30 PM as advertised. Motion by Kehn, seconded by Hutchison, to approve continued use of private road contracts when no private contractor is available or in emergencies, as per SDCL 31-11-44 through 45. With no further discussion and all voting yes, the motion carried.

Diaz Takes The Shield joined the meeting at 12:44 PM.

Susie Hayes, Director of Equalization, met with the Board to discuss valuation intentions for 2014 and the possibility of a future countywide reappraisal. Compiling a listing of delinquent taxes for a tax sale was discussed.

Nick and Andrew Tilsen presented the Board with an update on the Thunder Valley Community Development Corporation, a not-for-profit planned community project.

Sheriff Jim Daggett presented his monthly report.

Archie Hopkins, Veterans Services Officer, met with the Board for a final time before his retirement. Chairman Yellow Bull expressed the Board's gratitude for his years of service, presenting him with a certificate of appreciation. Motion by Hutchison, seconded by Diaz Takes The Shield, to accept the resignation of Archie Hopkins. With no further discussion and all voting yes, the motion carried.

Motion by Hutchison, seconded by Kehn, to enter into Executive Session for personnel interviews, per SDCL 1-25-2 (1). With no further discussion and all voting yes, the motion carried and the Board went into Executive Session at 2:04 PM.

The Board came out of Executive Session at 2:38 PM. Motion by Kehn, seconded by Hutchison, to offer the part-time VSO position to Lynette Quinsaat, at a salary of \$13,393.80 per year. With no further discussion and all voting yes, the motion carried and the position was offered to Quinsaat, who accepted.

Motion by Kehn, seconded by Diaz Takes The Shield, to approve travel for Quinsaat to attend training in Sioux Falls on February 18-19, 2014. With no further discussion and all voting yes, the motion carried.

Motion by Kehn, seconded by Hutchison, to approve bills as presented with the exception of claims from the Yankton County State's Attorney, Yankton County Sheriff, Creighton Thurman, Audra Malcomb Consulting, Rapid City Regional Hospital, Pennington County State's Attorney, Lewis and Clark Behavioral Health Services, Lincoln County Treasurer, Pennington County Public Defender, Lucy Lewno, Karen Swanda and Denise Cody as they are mental illness related expenses for which the county is not responsible. With no further discussion and all voting yes, the motion carried.
