## **SHANNON COUNTY MINUTES OF APRIL 26, 2013**

The Shannon Board of County Commissioners met in special session on April 26, 2013. Present: Anna Diaz, Lyla Hutchison, Eugenio White Hawk, and Auditor Sue Ganje. Present via speakerphone: Bryan Kehn. Absent: Wendell Yellow Bull.

The meeting was called to order at 12:20 PM by Vice-chairman Kehn. The agenda was reviewed for conflicts; none were identified. Motion by Hutchison, seconded by Diaz, to approve the agenda as written. With no further discussion and all voting yes, the motion carried.

The Board convened as the Board of Equalization and the members took the Oath of Office, which were placed on file.

Director of Equalization Susie Hayes met with the Board to present a filed appeal and explain the adjustment. Motion by Hutchison, seconded by White Hawk, to approve the stipulated value on appeal #2013-01, property owned by James and Marla Sauser, which would reduce the valuation on parcel 03746-31100 from \$43,270.00 to \$42,540.00, parcel 03646-17300 from \$39,840.00 to \$32,410.00 and parcel 03647-24300 from \$66,450.00 to \$53,730.00. With no further discussion and all voting yes on a roll call vote, the motion carried.

The Board began the review of the exempt list. Wendell Yellow Bull joined the meeting at 12:31 PM. Motion by Yellow Bull to approve the 2013 exempt list as presented. The motion died for lack of a second.

Motion by Diaz, seconded by White Hawk, to approve the 2013 exempt list as presented with the exceptions of allowing an exemption of five acres for properties owned by St. Matthew's Church and the Seventh Day Adventist Church. With no further discussion and all voting yes on a roll call vote, the motion carried.

Yellow Bull assumed chairing the meeting at 12:36 PM. Motion by White Hawk, seconded by Diaz, to adjourn as the Board of Equalization and reconvene as the Board of Commissioners. With no further discussion and all voting yes on a roll call vote, the motion carried and the Board convened as the Board of Commissioners at 12:50 PM.

Frank Maynard, Emergency Management, met with the Board to discuss issuance of a Disaster Declaration related to the snowstorm that began on April 9, 2013. A declaration may provide reimbursement for qualifying costs associated with the storm. Motion by Kehn, seconded by White Hawk, to approve a Disaster Resolution as follows, which was signed by Yellow Bull on April 23, 2013. With no further discussion and all voting yes on a roll call vote, the motion carried.

## SHANNON COUNTY RESOLUTION #2013-03 WINTER STORM DISASTER DECLARATION

WHEREAS, a severe winter storm has hit Shannon County, South Dakota, beginning April 9, 2013; and,

WHEREAS, said winter storm has caused extensive damage to critical infrastructure and threatened the health and safety of residents within Shannon County; and

WHEREAS, the winter storm will require extensive repair of critical infrastructure and removal of debris within Shannon County;

NOW, THEREFORE, BE IT RESOLVED by the Shannon County Board of Commissioners that they do hereby request that Shannon County be designated a disaster area due to the severe winter storm and request the Governor of the State of South Dakota declare an emergency/disaster to exist in Shannon County, South Dakota.
