

OGLALA LAKOTA COUNTY APPROVED COUNTY BOARD OF EQUALIZATION
MINUTES OF APRIL 19, 2019

The Oglala Lakota County Board of Equalization met in special session on April 19, 2019. Present: Ramon Bear Runner, Eugenio White Hawk, Wendell Yellow Bull and Sue Ganje, Auditor. Art Hopkins and Anna Takes the Shield were absent.

The Pledge of Allegiance was given, and the meeting called to order at 10:32 a.m. by Vice Chairman White Hawk. The agenda was reviewed for conflicts. ALL MOTIONS RECORDED IN THESE MINUTES WERE PASSED BY UNANIMOUS VOTE, UNLESS OTHERWISE STATED.

Motion made by Bear Runner, seconded by Yellow Bull, to approve the agenda as written.

Susie Hayes, Director of Equalization presented the packet of responsibilities. The Oath of Office was taken by the members and placed on file with the Auditor. The responsibilities of the Board, as set by the South Dakota Dept. of Revenue, were reviewed. Local Board minutes were reviewed.

Motion made by Yellow Bull, seconded by Bear Runner, to approve the Town of Batesland local board minutes.

The 2019 exempt list was reviewed. Motion made by Bear Runner, seconded by Yellow Bull, to approve the new applications for Youth Evangelism Strategies (2).

Motion made by Bear Runner, seconded by Yellow Bull to approve the new applications for Thunder Valley Subdivision as follows: Lot 1R, Blk 1; Lot 2, Blk 1, Blk 3; Lot 2, Blk 3; Lot 3, Blk 3; 2011 Mobile Home on Lease Site and 2016 Mobile Home on Leased Site. Motion made by Yellow Bull, seconded by Bear Runner, to support the recommendation of Director of Equalization Hayes and make no change to the appeal for Dale Pine, #55000-04147-113-10, #2019-02.

Motion made by Bear Runner, seconded by Yellow Bull, to adjourn as a board of equalization at 11:32 a.m.
