Motion by Hutchison, seconded by Kehn, to approve travel for VSO Lynette Quinsaas to attend training on August 25-27, 2014 in Pierre, SD. With no further discussion and all voting yes, the motion carried.

The Board reviewed the 2014 primary election report submitted by Jean Belt, Lakota Elections Coordinator, and commended her and assistant Agnes Westover. Motion by Kehn, seconded by Takes The Shield to approve and place on file the 2014 Primary Election report. With no further discussion and all voting yes, the motion carried.

Motion by Kehn, seconded by White Hawk, to approve County Tax Deed #2014-01 for Nikki Sue Yellow Hair in the amount of \$100.00 for Lot Eighteen (18), Block Four (4), Village of Batesland, Shannon County, SD. With no further discussion and all voting yes, the motion carried.

Frank Maynard, Emergency Management, informed the Board that the Shannon County and OST PDM has been finalized and submitted for approval. The PDM will be on the county website for review and, as it is the first such tribal and government agency joint plan, it will be used by others as a model.

Motion by Hutchison, seconded by Kehn, to approve a private road contract for Anthony Merdanian for \$126.00, which is paid. With no further discussion and all voting yes, the motion carried.

The Board reviewed the 2015 Highway Department budget proposal and fuel quotes.

Motion by Kehn, seconded by Hutchison, to approve Westco's bids of \$3.229 per gallon for 520 gallons of Unleaded and \$3.295 per gallon for 2,000 gallons of #2 Diesel as the only bids. With no further discussion and all voting yes, the motion carried.

Susie Hayes, Director of Equalization, presented her 2015 budget and reviewed the 2015 payable Abstract Recap. A map of delinquent tax parcels was examined and future ag land adjustments were discussed.

Kelli Rhoe, Treasurer, met with the Board for her 2015 budget request and Ganje presented the same for the Auditor's Office and Elections.

A request from the Department of the Army for comments on funding priorities for the Formerly Used Defense Sites military munitions response program. Motion by Kehn, seconded by White Hawk, to request additional information on the request from the Army Dept. With no further discussion and all voting yes, the motion carried.

Ganje told the Board that petitions were filed to change the county name to Oglala Lakota County and it appears that the circulators have fulfilled the minimum number of signatures needed to have the initiated measure on the November ballot, upon approval of the

ballot format by the Deputy State's Attorney. Discussion was held on the costs associated with changing the county name.

The Board discussed liquor sales and the fact that there is no regulatory power for enforcement.

Motion by Hutchison, seconded by Takes The Shield, to accept and place on file the report of VSO Quinsaat. With no further discussion and all voting yes, the motion carried.

Motion by Takes The Shield, seconded by White Hawk to approve the bills as presented, with the exception of the following bills for mental health costs: Pennington County Public Defender for \$26.00; Audra Malcomb Consulting for \$596.47; Pennington State's Attorney for \$215.00 and Pennington County Sheriff for \$395.55. With no further discussion and all voting yes, the motion carried.
