OGLALA LAKOTA COUNTY UNAPPROVED MINUTES OF AUGUST 14, 2019

The Oglala Lakota Board of County Commissioners met in regular session on August 14, 2019. Present: Ramon Bear Runner, Eugenio White Hawk, Wendell Yellow Bull and Sue Ganje, Auditor. Art Hopkins and Anna Takes the Shield were absent.

The Pledge of Allegiance was given, and the meeting called to order at 1:13 p.m. by Vice-chairman White Hawk. The agenda was reviewed for conflicts. ALL MOTIONS RECORDED IN THESE MINUTES WERE PASSED BY UNANIMOUS VOTE, UNLESS OTHERWISE STATED.

Motion made by Bear Runner, seconded by Yellow Bull, to approve the agenda as written.

Motion made by Yellow Bull, seconded by Bear Runner, to approve the minutes of July 10, 2019.

Motion made by Yellow Bull, seconded by Bear Runner, to table the General Fund Surplus Analysis until later in the meeting.

Ganje gave a brief summary of the 2-1-1 service. In recent legislation, the state has approved matching funds for counties statewide, based on population. Oglala Lakota County's 211 cost is \$13,403, with county match in the amount of \$6,701.50. Motion made by Yellow Bull, seconded by Bear Runner, to table the 211 Helpline Application survey until the next meeting and have the auditor invite a representative of the program to an upcoming meeting.

Lynx Bettelyoun, Highway Superintendent, met with the board. Discussion was held on road maintenance (between storms), reshaping County Road 7, and trying to get culverts in. Central air replacement is done in the office and the new camera system has been installed. There have been some internet issues, but this is being worked on.

Motion made by Yellow Bull, seconded by Bear Runner, to approve the sheriff fuel transfers for 168.9 gallons at \$2.766 per gallon, for a total of \$467.18.

Art Hopkins joined the meeting at 1:47 p.m.

Joe Herman, Sheriff, met with the board. Discussion was held on incidents, vehicle transfer, radios and a MOU with the jail, and noted he will not provide gun training due to liabilities.

Motion made by Yellow Bull, seconded by Bear Runner, to accept the report from Bettelyoun.

Motion made by Yellow Bull, seconded by Bear Runner to accept the report from Herman.

Kelli Rhoe, Treasurer, met with the board. Discussion was held on a satellite office 2 days a month in Pine Ridge, and the costs involved. Rhoe is still waiting to hear from the state on costs for a Kiosk. The Kiosk would be available for renewals only, but if the Treasurer came down 2 days a month, renewals, title transfers, and all other transactions normally done at the Treasurer's office would be available. Location and security issues need to be resolved. Rhoe gave an estimate on coming to the county 2 days a month as follows: \$16,000.00 for startup costs, and annual costs at an estimate of \$13,587.62. Currently there are still unknown costs. Rhoe also gave an estimate of \$247,995.00 - \$338,613.00 annually for there to be a full time Treasurer's office in Oglala Lakota County.

Motion made by Yellow Bull, seconded by Bear Runner to approve the preliminary estimate for Kiosk and satellite office; possible ROD in future.

Susie Hayes, Director of Equalization, met with the board. Motion made by Yellow Bull, seconded by Bear Runner, to approve the abatement for Glen Gibbons, parcel #20000-03744-10200, tax year 2018, pay 2019, in the amount of \$1,062.32. Reason: the board agreed the parcel should be valued as agriculture as they now have the agriculture audit filled out and filed.

A report was given by Frances Denison, Director of Equalization Deputy, about some of the recent trainings they have attended and gave examples of some knowledge they obtained. Discussion was also held on when conference will be held in Hot Springs in 2021 and things that the commissioners could take part in.

Ernie Little, representing Little Wound District, met with the board. Motion made by Yellow Bull, seconded by Bear Runner, to approve the following resolution:
