Lynx Bettelyoun, Highway Superintendent, met with the board to give updates on the installation of 3 culverts on County Road #11 (Gordon Junction) that was nearly done. Bettelyoun has been working with FEMA on damaged roads. He also noted issues with Dakota Contractors on the current road project (County Road #11) on the completion timeline. Discussion was held on possible weigh stations on county roads, Herman will work on partnering with the Tribe. Hopkins commended Bettelyoun and crew on the super job they were

Motion made by White Hawk, seconded by Yellow Bull, to approve the sheriff fuel transfers of 151.80 gallons at \$2.516 per gallon, for a total of \$381.93 to reimburse the highway department.

Joe Herman, Sheriff, met with the board and presented his monthly report. Discussion was held on Herman's office at the Highway Shop in Batesland, having a local probation office,

blood draws, hiring grants and the possibility of hiring a deputy, jurisdictional issues and concerns.

Motion made by Yellow Bull, seconded by White Hawk, to accept the sheriff's monthly report and place it on file.

Motion made by White Hawk, seconded by Yellow Bull, to table the report on the conference in Washington, DC from Bear Runner.

A break was taken at 2:47 p.m. and the meeting resumed at 2:58 p.m.

Discussion was held on brand laws and hiring an investigator for Oglala Lakota County. Concerns were raised about livestock transfers and getting brand inspectors in the county due to jurisdictional issues. Lyla Hutchison, past brand board member, discussed shipping agreements and open markets, as well as trials that were faced and enforcing brand laws. Dan Bothwell was recommended as a good resource. Bothwell is a chief investigator for the state brand board. Discussion was also held about the possibility of a tribal investigator, or working with county law enforcement, tribal leases and infectious diseases. Yellow Bull would like a letter to go to the congressional delegation and have aids attend a meeting to help get the issue resolved.

Motion made by Yellow Bull, seconded by White Hawk, to table the Home Rule discussion until the next meeting.
