Motion made by Yellow Bull, seconded by Bear Runner, to approve the hazard pay for election workers in the amount of \$175.00 for election day superintendents and \$165.00 for election day non-superintendents (not including election school).

Motion made by Yellow Bull, seconded by White Hawk to extend and re-advertise sealed bids for the 1993 Cat 140 G Motor Grader and open them at the December 9, 2020 meeting.

Lynx Bettelyoun, Highway Superintendent, updated the board that they have been working on snow removal on County Road 7, as well as working on equipment and road graders. Bettelyoun spoke of helping with the election, delivering personal protective equipment to fire departments and looking for a building to store the Sheriff's two Side x Sides. Discussion was also held on road emergencies during storms and use of the county highway department. These services could be billed to the Oglala Sioux Tribe. Bear Runner asked for a resolution to be drawn up by the State's Attorney to be put in place for the future.

Commissioner Yellow Bull commended the Oglala Lakota Highway Department for loss control and safety benefits. Yellow Bull presented Bettelyoun with a plaque from Safety Benefits.

A hearing for the distribution of the 2020 Fire Insurance Monies was held upon the request of the Interior Volunteer Fire Department. Present were Will Smith of the Batesland Fire Department and Jamie Big Crow of the Kyle Volunteer Fire Department. Discussion was held on responses by each department, and that each of the two departments respond to fires in Jackson and Bennett counties. Motion made by Yellow Bull, seconded by White Hawk, to deny the Interior Volunteer Fire Department request for monies and leave fire insurance lines as determined in 2019, with 51% going to Batesland Fire and 49% going to Kyle Fire for 2020 fire insurance distribution.

Susie Hayes, Director of Equalization, met with the board to advise of the need for add-ons as a result of property coming out of tax-exempt status to taxable status. Motion made by Yellow Bull, seconded by Hopkins, to set a hearing for December 9, 2020 at 1:10 p.m. for omitted property (pro-rated amounts) for pay 2021 taxes on properties sold by Thunder Valley CDC.

Discussion was held on new housing by Kyle on deeded land, owned by the Oglala Sioux

Tribe. John Long, BIA, will have more information.

Hayes spoke of fall appraisals in Oglala Lakota County; the board recommended getting in contact with Sheriff Herman before coming.

No supplement and contingency hearing was held.

Teresa Pullen, Treasurer, met with the board. Motion made by Yellow Bull, seconded by White Hawk, to allow the treasurer to change the current credit card company to First Interstate Bank.

DeCora Testerman, homeowner at the Thunder Valley CDC (Community Development Coorporation), met with the board to discuss a spike in property taxes at Thunder Valley Development. Testerman explained that the majority of the homeowners were under 30, but that the tax increase was difficult for the owners. Discussion was held on low income loans, lender issues if land is put in trust, and the lack of previous sales, but that current sales were now creating the market value. Other owners also spoke of the situation. Hayes noted the upcoming assessment notices that will come to the landowners, but she would do research to see if she can find any way to help.

Joe Herman, Sheriff, met with the board, via phone, to discuss that the current deputy will not be able to go to full-time as the board authorized. Herman would like to hire a temporary deputy through December 31, 2020 or the possibility of a constable. Motion made by Bear Runner, seconded by Hopkins, to approve having the sheriff find a full-time employee and hold a special meeting when one is found.

Discussion was also held on the Homeland Security grant to purchase 2 side by sides and radios.

Motion made by Yellow Bull, seconded by White Hawk, to table the county housing board discussion.

Official Canvass for the 2020 General Election was conducted. Motion made by Yellow Bull, seconded by Bear Runner, to approve the Official 2020 General Election Canvass.

No public comment was heard. Motion made by Yellow Bull, seconded by Hopkins, to adjourn at 5:13 p.m.
