The Oglala Lakota Board of County Commissioners met in regular session on February 10, 2021. Present: Art Hopkins, Eugenio White Hawk, Wendell Yellow Bull and Sue Ganje, Auditor. Ramon Bear Runner and Anna Takes the Shield (DuBray) were not present.

The meeting called to order at 1:32 p.m. by Vice-Chairman White Hawk. The agenda was reviewed for conflicts. ALL MOTIONS RECORDED IN THESE MINUTES WERE PASSED BY UNANIMOUS VOTE, UNLESS OTHERWISE STATED.

Ramon Bear Runner joined the meeting (via phone) at 1:48 p.m.

Motion made by Yellow Bull, seconded by Hopkins, to approve setting a supplement hearing on March 10, 2021 at 1:10 p.m.

Motion made by Yellow Bull, seconded by Hopkins, to approve appointing Bear Runner to the Weed Board with no compensation.

Motion made by Yellow Bull, seconded by Hopkins, to accept the VSO Monthly Activity Report for December 2020.

Bear Runner noted that OST wants to keep tribal VSO separate from County VSO.

The hearing for sealed bids on Oglala Lakota County Road 7 Aggregate Resurfacing Project was held as advertised. A bid was received by Western Construction Inc., Rapid City in the amount of \$531,350.00.

Motion made Yellow Bull, seconded by Bear Runner, to approve the bid from Western Construction Inc., Rapid City, in the amount of \$531,350.00, contingent on proper bid documentation and paperwork.

Lynx Bettelyoun, Highway Superintendent, met with the board and presented fuel quotes as follows:

Motion made by Yellow Bull, seconded by Bear Runner to approve the January 7, 2021 through February 6, 2021 sheriff fuel transfer to reimburse the highway for 247.1 gallons of fuel at \$1.967 per gallon, for a total of \$486.05 and to accept the low and only bid from Westco for \$2.316 per gallon for 500 gallons of unleaded gas, for a total amount of \$1,158.00, \$2.449 per gallon for 600 gallons of diesel, for a total of \$1,469.40 and \$1.749 per gallon for 700 gallons of propane, for a total of \$1,224.30.

Motion made by Yellow Bull, seconded by Hopkins, to approve purchasing 2021 culverts off the Beadle County bids.

Bettelyoun updated the board that repairs were being done on machinery – installing beacons on gravel trailers and back up alarms on needed equipment, CR7 and CR11 have been bladed, repairs to a road grader, the 2008 Kenworth has been serviced and had a brake job and converted the shop indoor lights to LED. Discussion was held on MSHA training, the new road grader and appreciation for employees.

Takes the Shield (DuBray) joined the meeting at 2:13 p.m. via phone and White Hawk turned the meeting over to the chair at 2:23 p.m.

The Private Road Work Hearing as per S.D.C.L. 31-11-41 - 31-11-45 was held as advertised. Motion made by Yellow Bull, seconded by White Hawk, to continue with private road work as per S.D.C.L. 31-11-41 - 31-11-45.

Allen Schaefer, SD Department of Legislative Audit, met with the board for his entrance conference for 2018 - 2019 audit. Motion made by Yellow Bull, seconded by White Hawk, to approve the engagement letter for 2018 - 2019 audit and authorize the vice-chairman to sign.

Susie Hayes, Director of Equalization, was unavailable to meet with the board.

Robert Two Crow was unable to attend the meeting for the discussion on Lakota Language in Oglala Lakota Schools. A bill put forward during legislation failed. The intent is to have the Lakota Language as part of the regular curriculum, not as an elective. Twila Hopkins spoke that the Lakota Language is sacred, but not as used by the Lakota Language Consortium Curriculum. Hopkins noted the influence of education in the classroom, but that it needs to be done correctly with the input from Lakota people. Art Hopkins noted money that the drafters of the LLCC have made, and White Hawk spoke of the books in the classroom that teachers were not utilizing. Motion made by Hopkins, seconded by White Hawk, to table discussion until a future date.

Commissioner Takes the Shield (DuBray) updated the board that after 6 years there was a site visit for the Motor Vehicle Kiosk in Pine Ridge on February 9, 2021. Discussion was held on how to split costs; we will wait and see the outcome.

Commissioner Bear Runner spoke of increasing the Veteran's Service Officer from parttime to full-time if there was a possibility of getting Covid funds to assist with the cost. Motion made by Bear Runner, seconded by White Hawk, to table making the Veteran's Service Officer full-time until the March meeting.

Commissioner Yellow Bull spoke of the board's goal of changing the home rule to elect their own State's Attorney, and the petition process needed. Yellow Bull also spoke on the process to create the county housing board, Covid funds, serving paperwork on people with regards to child support, and cattle and horse theft issues. Lance Russell, State's Attorney will work with the service process on tribal members and send Attorney Sword a letter on the child support papers.
