

PETITION FOR VACATION OF PLAT

The undersigned petitioner makes this petition pursuant to SDCL 11-3-21.1 to vacate the plat for the real property described on Exhibit A which is attached hereto and incorporated by reference and states as follows:

- 1. The name and address of the only record owner of the platted real property to be vacated is: Oyate Concern, Inc., a South Dakota nonprofit corporation whose post office address is PO Box 148, Oglala, SD 57764.
- 2. The legal description of the plat to be vacated is as follows:

Tract 1 located in the Southwest Quarter (SW1/4) of Section Eleven (11) Township Thirty-Seven (37) North, Range Forty-Six West of the Sixth Principal Meridian, Oglala Lakota (formerly Shannon) County, South Dakota filed for record on October 1, 1985 in Book XIII of Plats page 70 in the Office of the Register of Deeds, serving Fall River and Oglala Lakota Counties, South Dakota.

- 3. There are no legal voters residing on the platted real property.
- 4. That those who signed as the Owners on the above-described plat were Wallace L. Finder and Leonard A. Finger.
- 5. That at the time that the plat was prepared the real property was not owned by Wallace L. Finger or Leonard A. Finger; that a patent was issued to Wallace Little Finger a/k/a Wallace Finger and Leonard A. Finger a/k/a Leonard Anthony Finger on April 7, 1986 and recorded on April 26, 1986 in Book 4 of Patents page 204 in the Office of the Register of Deeds, serving Fall River and Oglala Lakota Counties, South Dakota.
- 6. That said platted description has never been used in a conveyance in the chain of title; by Warranty Deed dated August 26, 1986 Wallace Little Finger and Leonard A. Finger and Theresa Finger, his wife, deeded the W1/2SW1/4SW1/4 of Section 11, Township 37 North, Range 46 West of the Sixth Principal Meridian, Shannon County, South Dakota to the Lakota Baptist Church; said deed recorded in Book 10 of Deeds, pages 16-17 in Office of the Register of Deeds, serving Fall River and Oglala Lakota Counties, South Dakota.


- 7. That by Warranty Deed dated January 9, 2019, the Lakota Baptist Church deeded the W1/2SW1/4SW/14 of Section 11, Township 37 North, Range 46 West of the Sixth Principal Meridian, Oglala Lakota County (formerly Shannon County) South Dakota, which said deed was recorded on January 11, 2019 in Book 13 of Deeds, pages 48-49 in the Office of the Register of Deeds, serving Fall River and Oglala Lakota Counties, South Dakota.
- 8. That the entire platted area is within the W1/2SW1/4SW1/4 of Section 11, Township 37 North, Range 46 West of the Sixth Principal Meridian, Oglala Lakota (formerly Shannon) County, South Dakota.
- 9. That located on the plat is "Old Highway 18" in the far southwest corner. As set forth and identified on the Record of Survey dated Oct. 12, 2018 and attached hereto as Exhibit "B", the "Old Highway 18 Old Alignment" has been moved and is shown as "Old Highway 18 New Alignment" which is on the section line and not on the platted real property. The granting of this petition will not authorize the closing or obstruction of any public highway laid out.
- 10. Petitioner requests that the above-described plat be vacated as it is a "wild plat" on the chain of title.
- 11. That this vacation is subject to the following easements (none of which reference the platted description) all of which are recorded in the: Office of the Register of Deeds, serving Fall River and Oglala Lakota Counties, South Dakota as set forth below:
 - A. Right of way easement between Lakota Baptist Church and Lacreek Electric Association dated Dec. 12, 2011 and recorded on Dec. 19, 1986 in Book 9 page 414;
 - B. Right of Way Easement between Lakota Baptist Church and Lacreek Electric Association dated November 16, 2004, and recorded on August 13, 2008, in Book 15 of Miscellaneous page 29; and
 - C. Temporary Easement Agreement between Lakota Baptist Church and the State of South Dakota dated June 8, 2009 and recorded on June 17, 2009.
- 12. That the granting of the petition will not abridge or destroy any of the rights and privileges of other proprietors of such plat and will not authorize the closing or obstruction of any public highway laid out.

Wherefore the Petitioner petitions the Oglala Lakota County Commission, pursuant to SDCL 11-3-22, set a time and place for a hearing on this petition with the hearing to be held within thirty days of the filing of this petition with the Commission holding least one public hearing; that notice of the time and place of the hearing be given once at least ten days in advance by publication in a legal newspaper of Oglala Lakota County and following said hearing the Oglala Lakota County Commission grant this petition vacating the said plat.





WHEREAS, Oyate Concern, Inc., a South Dakota nonprofit corporation, whose post office address is PO Box 148, Oglala, SD 57764, having heretofore presented to the Oglala Lakota County Commission, a Petition for vacation of the following:
