The Oglala Lakota Board of County Commissioners met in regular session on May 12, 2021. Present: Anna Takes the Shield (DuBray) (via phone), Eugenio White Hawk, Wendell Yellow Bull (via phone) and Sue Ganje, Auditor. Ramon Bear Runner and Art Hopkins were not present.

The Pledge of Allegiance was given, and meeting was called to order at 1:28 p.m. by Chairwoman Takes the Shield (DuBray). The agenda was reviewed for conflicts. ALL MOTIONS RECORDED IN THESE MINUTES WERE PASSED BY ROLL CALL AND UNANIMOUS VOTE, UNLESS OTHERWISE STATED.

Motion made by Yellow Bull, seconded by White Hawk, to approve the agenda, with the addition of the ITI agreement.

Motion made by White Hawk, seconded by Yellow Bull, to approve the April 14, 2021 minutes.

Motion made by Yellow Bull, seconded by White Hawk, to accept the Veteran's Service Officer monthly report and place it on file.

Motion made by White Hawk, seconded by Yellow Bull, to approve the Auditor's Account with the Treasurer as follows:

Motion made by White Hawk, seconded by Yellow Bull, to approve Ganje and Takes the Shield (DuBray) as American Rescue Plan Administrative Designees.

Motion made by Yellow Bull, seconded by White Hawk, to table setting a hearing for the fire departments certified in 2020 by the State Fire Marshall, until it is confirmed that other neighboring counties will be following the same law on distribution of funds.

Lynx Bettelyoun, Highway Superintendent, met with the board. Motion made by Yellow Bull, seconded by White Hawk, to approve the March 25, 2021 through April 25, 2021 sheriff fuel transfer to reimburse the highway for 139 gallons of fuel at \$2.765 per gallon, for a total of \$384.34.

Motion made by Yellow Bull, seconded by White Hawk, to approve the low and only bid from Westco for 350 gallons of gasoline at \$2.765 per gallon, for a total of \$967.75 and 1,700 gallons of ruby diesel, at \$2.619 per gallon, for a total of \$4,452.30.

Motion made by Yellow Bull, seconded by White Hawk, to approve hiring Angela Bush, administrative assistant for the Highway Superintendent and Sheriff's Office, 30 hours per week, at \$14.00 per hour, effective May 17, 2021.

Bettelyoun updated the board on maintenance of County Roads 11, 13, 16A, 16, 2, 4, and 7, along with the streets of Batesland. 425 tons of gravel have been hauled to County Road 11 and they have reshaped 2 miles of County Road 7. Advisement was given that contractor Bob Lee has changed his business name to Lee Ranch Trucking. That trucking project will begin approximately in mid-June. The County Road 7 project will begin in August.

Hopkins joined the meeting at 1:42 p.m.

Susie Hayes, Director of Equalization and Stacey Martin, GIS, met with the board to discuss the new Ag Soil Tables, and how it would affect Oglala Lakota County. The proposed soil changes to Class 4 soils results in a classification change of grass to crop, with increased values. There will be an upcoming meeting between Hayes, Martin with the Department of Revenue at the end of May. Hayes and Martin will update the board after their meeting with SD Revenue.

Takes the Shield (DuBray) exited the meeting at 1:58 p.m.

Yellow Bull physically joined the meeting at 2:08 p.m.

Hayes introduced Frances Denison, who is the President of the Director of Equalization Association, conference will be hosted in Hot Springs this year and the Oglala Lakota Commissioners are welcome to come.

Break was taken at 2:36 p.m. and meeting resumed at 2:41 p.m.

Lance Russell, State's Attorney, met with the board to discuss the ITI self-service terminal services contract for the Kiosk that will be at the Tribal building in Pine Ridge. Russell would like more time to look over the contract and address some of the issues that concern him, referring to the cost which is not addressed, liability issues, the contract was written in the State of Indiana and the possible need for a Tribal official's signature as well.

Motion made by Yellow Bull, to authorize Lance Russell, State's Attorney, to create an agreement for the ITI self-service terminal between the County and Tribe. Motion dies for lack of a second.

Motion made by Yellow Bull to authorize the vice-chairman of the board to assist the state's attorney and the treasurer with this matter. Motion dies for lack of a second.

Russell will speak with the legal and executive committees for the Tribe and work with the Treasurer on the matter.

Russell spoke on medical cannabis, noting the need for an ordinance, of which the State's Attorney Association is working on. A distillery will need to be approved by the commission, and further noted the jurisdiction issues. A sample ordinance will be put forth at the next meeting, where other issues will be addressed.

Takes the Shield (DuBray) re-joined the meeting via phone at 3:18 p.m.

Discussion was held on hiring an investigator to help with livestock theft issues and statues that will help with this matter. Russell noted that SD law allows for a special agent to be hired. It is believed that 2,000 head of cattle have been stolen in the last 10 years. There is a need for an investigator, and for that individual to train OST Law Enforcement. All entities need to work together on this issue.

Curtis Temple and Doris Respects Nothing met with the board to request help from the County and clarification on jurisdiction of the County Sheriff on deeded land. Temple spoke of cattle being stolen and changes in the lease that he had with the tribe. Motion made by Yellow Bull, seconded by Hopkins, to have Temple bring all paperwork on cattle issue to provide to State's Attorney Russell for opinion.

Sue Ganje, Auditor, met with the board to give a review of the 2020 annual report.

Motion made by Yellow Bull, seconded by White Hawk, to approve the bills, as follows:
