## OGLALA LAKOTA COUNTY APPROVED MINUTES OF AUGUST 30, 2021

The Oglala Lakota Board of County Commissioners met in special session on August 30, 2021. Present: Ramon Bear Runner (via phone), Art Hopkins, Anna Takes the Shield (DuBray) (via phone), Eugenio White Hawk, Wendell Yellow Bull and Aaron Eberle, Auditor's Administrative Assistant.

The Pledge of Allegiance was given, and meeting was called to order at 1:18 p.m. by Chairwoman Takes the Shield (DuBray). The agenda was reviewed for conflicts. ALL MOTIONS RECORDED IN THESE MINUTES WERE PASSED BY ROLL CALL AND UNANIMOUS VOTE, UNLESS OTHERWISE STATED.

Motion made by Bear Runner, seconded by White Hawk, to approve the agenda as written.

The board reviewed Ordinance #2021-01 and made the following designations to the Medical Cannabis Ordinance.

Motion made by Yellow Bull, seconded by White Hawk, to approve requiring that a current and valid cannabis establishment license be issued by the county; and that there be a valid and current cannabis establishment registration certificate issued by the Department of Health, both with violations of this provision be subject to the general penalty provision in Chapter 3 to Ordinance 2021-01.

Motion made by Yellow Bull, seconded by White Hawk, to set the fee for an application for a cannabis establishment license to be \$5,000.00 in Section XX.04 License Application, (b) under #1.

Motion made by Yellow Bull, seconded by White Hawk, to approve setting 1,000 feet in Section XX.07 (a) under Cannabis Dispensary.

Motion made by Yellow Bull, seconded by Hopkins, to approve 1 cannabis dispensary and the hours of operation will be from 9:00 a.m. to 7:00 p.m., Monday through Saturday, closed on Sunday under Section XX.07 Locations, #3 General Provisions and Performance Standards for Dispensaries.

Bear Runner exited the meeting at 1:55 p.m. and returned at 2:00 p.m.

Motion made by Yellow Bull, seconded by Hopkins, to approve setting 500 feet under Section XX.07 (b) under Cannabis Cultivation Facility and Section XX.07 (c) under Cannabis Testing Facility.

Motion made by Yellow Bull, seconded by Hopkins, to approve setting 1,500 feet under Section XX.07 (d) under Cannabis Product Manufacturing Facility.

Motion made by Yellow Bull, seconded by Hopkins, to approve \$5,000.00 for a renewal fee under sections XX.09 Expiration of License and Renewal fee (b).

Motion made by Yellow Bull, seconded by Hopkins, to approve the first reading of Ordinance 2021-01, an Ordinance adding Chapter 3 to the revised ordinances of Oglala Lakota County creating licensing provisions for cannabis establishments.
