Oglala Lakota County Commissioners,

Wounded Knee District School is asking for funding assistance to repair Water Tower Control system for School and school housing. We are currently using OST Rural Water and need tower for backup system. Attached are the revised repair estimates from Dakota Pump & Control (DPC) of Watertown, South Dakota and Electrical material and labor, from Kratovil Electric of Martin, South Dakota.

OST Rural water system had power surges and blew out our tower system. It is on the school side, so they are not responsible for damages, but the school needs to have the tower up and running to provide a backup system for school and housing. Due to Covid 19 Pandemic, we will need to have adequate water supply readily available for students and households.

We spent over \$39,000.00 in repairing tower and then the valves blew due to pressure surge from rural lines. We have no more funds for repairs in our budget and need to have the tower functioning. We made a request to I.H.S. Water and Sewer (James Begeman), and they tried to get it supported under a grant they received but it was denied.

Your help would be greatly appreciated.

This type of work is eligible under SRF/ARPA guidelines. Just remind the county that if they use ARPA funding that they will need to follow Uniform Guidance and Federal Procurement Policies. If the County chooses to grant the funds to Wounded Knee, the County will need to ensure the following:

- 1. Subawards in amounts exceeding \$25,000 require that the subrecipient have FFATA registration/login.gov.
- 2. Subrecipients must have written internal control policies and procedures.
- 3. Subrecipients must have their own Uniform Guidance Policies.
- 4. Subrecipients must have written cash management procedures
- 5. Subrecipients must have written Standards of Conduct to address conflict of interest, actions of employees, actions of governing officials engaged in selection, award, and administration of contracts.
- 6. Subrecipients must have established employee policies.
- 7. Subrecipients must have a Records Management Plan and a Records Retention Schedule addressing who has access and a training plan for employees.
- 8. Subrecipients and/or Recipient must complete a needs assessment for the project.
- 9. Subrecipients should be able to document their capability to understand and administrate according to Federal Procurement Policies (not the same as State Bid Law).
- 10. Subrecipients must show proof of clear audits.
- 11. Recipients (County) must have a process identified in how it will manage audit findings of a subrecipient for the duration of the project through project closeout.
- 12. Recipients (County) will need "written procedures that minimize the time elapsing between the transfer of funds and disbursement by the non-Federal entity, and financial management systems that meet the standards for fund control and accountability." This part is concerning to me because the County would have an obligation to ensure that the contractor's are paid on time, but ultimately you would have no control to ensure that happens.
- 13. Recipient (County) will need to have a policy or procedure for determining risk of subrecipients (risk assessment process). 2 CFR 200.331 (b)
- 14. Recipient (County) will need to establish rules or make a determination on indirect cost rates if the subrecipient doesn't already have a federally recognized indirect cost rate negotiated between the subrecipient and federal government; if no such rate exists a rate negotiated between the County and the subrecipient is required.
- 15. Recipient (County) is responsible for subrecipient monitoring and 2 CRF 200.332, 200.22, 200.23, and 200.74
- 16. Recipient (County) will need to adopt Uniform Rules for Federal Grants (if you haven't already)
- 17. Recipient (County) must notify subrecipient the funds qualify as a subaward and comply with 2 CFR 200.331 (a), 200,332,
- 18. Recipient (County) must establish appropriate terms and conditions concerning closeout of the subaward.

There are numerous other requirements (too many to list) included in the 2 CFR 200 regarding contracts, remedies for noncompliance, monitoring etc. Also, please note that if the County chooses to pay for these cost directly, the County is still obligated to comply with all of the things listed above, it would just be a simpler process since you wouldn't have to manage the subaward.
