#### OGLALA LAKOTA COUNTY UNAPPROVED MINUTES OF AUGUST 9, 2023

The Oglala Lakota Board of County Commissioners met in regular session on August 9, 2023. Present: Ramon Bear Runner, Allyssa Comer, Art Hopkins, Wendell Yellow Bull and Sue Ganje, Auditor.

The Pledge of Allegiance was given and meeting was called to order at 1:06 p.m. by Allyssa Comer, Vice-Chairwoman. The agenda was reviewed for conflicts. ALL MOTIONS RECORDED IN THESE MINUTES WERE PASSED BY UNANIMOUS VOTE, UNLESS OTHERWISE STATED.

Anna Takes the Shield, Chairwoman, called in at 1:10 p.m. but asked that Comer continue chairing the meeting.

Motion made by Yellow Bull, seconded by Hopkins, to approve the agenda with amendments changing the word surplus to restricted scheduled at 1:40 pm and change assigned to restricted on the second Resolution scheduled at 1:50.

Motion made by Yellow Bull, seconded by Hopkins, to approve the agenda with amendments.

Motion made by Yellow Bull, seconded by Takes the Shield (Dubray), to approve the meeting minutes from July 21, 2023 and August 3, 2023.

Motion made by Yellow Bull, seconded by Hopkins, to approve the Auditor's Account with the Treasurer for July, 2023 as follows:

Motion made by Yellow Bull, seconded by Takes the Shield (Dubray) for Allyssa Comer, Art Hopkins, Anna Takes the Shield (Dubray) and Wendell Yellow Bull to attend the State Tribal Opioid and Methamphetamine Prevention Summit on October 3, 2023 in Pierre.

Al Schaefer, SD State Legislative Audit, met with the Board to submit his report of the County Audit for 2020 and 2021. There were no written comments, but did comment on 2 funds with a negative balance on December 31, 2021. It is recommended that the County transfer funds to cover the deficit in the Emergency Management fund, which has since been discontinued. 2 Time sheets

were not signed by the employee and the supervisor, and 1 employee was overpaid 4 hours of overtime. The auditor noted that she would like some sort of electronic timeclock for employees. It is recommended that care be taken when figuring time worked for the calculation of wages due. One other item noted was that the County did not transmit to the State's Unclaimed Property Fund any outstanding checks that were older than one year, with Schaefer noting there are two laws pertaining to this in the codified laws, and the county is actively working on a resolution for approval.

Motion made by Bear Runner, seconded by Hopkins, to authorize Vice-Chairwoman Comer to sign the Audit Exit Letter.

Motion made by Yellow Bull, seconded by Hopkins, to table the request for funding in the amount of \$10,000.00 for the Oglala Lakota Nation Fair and Rodeo Pow Wow from Tyler Yellow Boy, Chairman of 2023 Oglala Lakota Nation Fair and Rodeo until he is present via telephone.

Anna Takes the Shield (Dubray) left the meeting at 1:44 pm.

Lynx Bettelyoun, Highway Superintendent, met with the Board to discuss the purchase of a snowblower that attaches to a front-end loader that had previously been approved but had been backordered. There was also discussion regarding the reimbursement that was received from the State and from FEMA. Approximate amounts equaled \$9,611.78 for both.

Motion made by Bear Runner, seconded by Yellow Bull, to approve payment to Fair Manufacturing for Snocrete model 948D snow blower in the amount of \$162,318.00 and \$1,000.00 for freight to ship to Batesland.

Discussion continued with Bettelyoun regarding a plan for construction of a new Highway Shop to also be used by the County Sheriff and the Veteran Service Office. Having a feasibility study done was recommended to help start the planning process, with Yellow Bull suggested contacting the SD School of Mines and Technology to see if the Engineering students could do it pro-bono as part of their college credits. Bear Runner suggested that Bettelyoun go to Morton Buildings to inquire about drafting plans for the proposed building.

Motion made by Yellow Bull, seconded by Bear Runner, to go to Morton Buildings in Rapid City to have them sketch out a proposed Highway Building.

Bettelyoun provided updates to the Board, which included blading, mowing and servicing equipment. Yellow Bull asked that the 13 miles of Grass Creek Rd be put back on the County System for families with school aged kids to use. Bettelyoun will bring back estimated costs to do so at the next meeting.

Takes the Shield (Dubray) re-entered the meeting via telephone at 2:15.

Motion made by Takes the Shield (Dubray), seconded by Bear Runner, to go into executive session for personnel at 2:23 pm with Anna Takes the Shield (Dubray) then leaving the meeting at 2:27 pm.

Comer, Vice-Chairwoman, declared the board be out of executive session at 2:39 pm.

Motion made by Bear Runner, seconded by Yellow Bull, to approve travel for Jerlene Arredondo, Veteran Service Officer, to attend the Annual Veteran Service Officer Conference in Sioux Falls, September  $5^{th} - 7^{th}$ , 2023.

The board also reviewed the VSO report. Motion made by Bear Runner, seconded by Yellow Bull, to accept the VSO report for July 2023 and place on file.

Motion made by Bear Runner, seconded by Yellow Bull, to move discussion on HB3372, opposing heavier trucks requested by GoRail, to the next meeting.

Motion made by Bear Runner, seconded by Yellow Bull, to use assigned funds on improvements at the site of the Highway Department in Batesland to include Highway maintenance area, room for Sheriff and VSO, and to include a large meeting room.

Hopkins noted that he would like to see Department Heads attending the Commissioner meetings, especially when they have a report or a request for travel. A notice should go out regarding this issue.

Motion made by Hopkins, seconded by Bear Runner, to accept Resolution #2023-07 with the change of "General Fund monies at a total cumulative amount <u>up to</u>" instead of the word "of", to read as follows:

#### OGLALA LAKOTA COUNTY RESOLUTION #2023-07

WHEREAS, the County desires to have a one-time only cap to funding requests from the General Fund monies at a total cumulative amount up to \$20,000.00 to assist public service-related organizations as outside sources, and;

WHEREAS, the County desires to only provide funding to businesses and/or non-profit organizations that provide public-service related services to residents of Oglala Lakota County, and;

WHEREAS, the County wants to preserve the funding for County purposes, and;

WHEREAS, the Oglala Lakota County Board of Commissioners is authorized to enact such limit;

NOW THEREFORE, BE IT RESOLVED, that the Board of Oglala Lakota County Commissioners will cap the funding to outside entities at a one-time only use of General Fund monies up to \$20,000.00 cumulative total; and that the Board of Oglala Lakota County Commissioners will only provide funding to businesses and/or non-profit organizations that provide public-service related services to residents of Oglala Lakota County.

WHEREAS, the County wants to preserve the funding for County and local government purposes, and;

NOW THEREFORE, BE IT RESOLVED, that the Board of Oglala Lakota County Commissioners will restrict \$1,000,000.00 of the Restricted General Fund surplus cash for use on improving the County Highway Shop in Batesland.

Bear Runner addressed the Board to speak on behalf of the Oglala Lakota Housing Authority regarding a change that OLHA would like to make by entering into an MOU with Behavior Management Systems regarding services to low income families. BMS sent them a proposal to assist with this. OLHA is requesting that the County contribute \$100,000.00 for the first year to help get things started. Bear Runner will bring this back to the next meeting with a presentation along with BMS. Discussion on some possible alternatives occurred.

Teresa Pullen, Treasurer, met with the Board do discuss Delinquent Property Tax payment plans, and Pullen requested they now be called Delinquent Tax Assistance. She provided samples of applications for individuals to fill out and recommended that the County follow the same guidelines as they do for County Assistance, which is based on the Federal Income Poverty level each year. She also was asking for guidance from the Board about certain criteria for being eligible for applying, including residing requirements, limits to the amount owed on back taxes, requirements on if the assistance should be for houses only or include vacant land, and time limits get the delinquent taxes current, noting that current taxes need to be kept current for the payment plan to remain in place. After discussion with the Board, Pullen noted the suggestions and will come to the next meeting with a proposed application form for them to review for approval.

Sue Ganje, Auditor, met with the Board to review the 2024 Provisional budget.

Motion made by Yellow Bull, seconded by Hopkins, to approve the 2024 Provisional budget. With discussion following. Yellow Bull asked for a 1-year only increase to the amount for attending the meetings, from \$25.00 to \$35.00. He also asked that the Commission salary be figured at \$500.00 per month in the '24 budget.

The Commissioners provided a brief report from the Human Trafficking workshop in Pierre. They attended the first day.

Vanessa Plume, Sheriff, met with the Board to provide her report from the entire training on the Human Trafficking workshop in Pierre. She stated that the information that was presented regarding the Dark Web was very informative. Social Media, code words, and other items were also discussed.

The Memorandum of Agreement between Prairie Wind Casino of the Oglala Sioux Tribe on the Pine Ridge Indian Reservation and Oglala Lakota County was discussed. State's Attorney Russell and Plume had gone through it and a few changes were made. The Board wants it to go back to the Tribe to be signed. Then Plume will bring it back for the Commissioner's signature.

There was discussion regarding jurisdiction between Tribal Law Enforcement and County Law Enforcement. Plume is still actively looking for a deputy. She also asked the Commissioners for their endorsement for her to talk to Tribal Law Enforcement to better work together and provide continuity in law enforcement.

#### Memorandum of Agreement

## Between the Prairie Wind Casino of the Oglala Sioux Tribe on the Pine Ridge Indian Reservation and Oglala Lakota County

#### For Law Enforcement Services

This Memorandum of Agreement (MOA) is made and entered into on this day of
, 2023, By and between Oglala Lakota County, the Prairie Wind Casino, and the
Oglala Sioux Tribe on the Pine Ridge Indian Reservation. This MOA will begin upon its execution
and renew on an annual basis.

#### 1. PURPOSE

To develop cooperative efforts between the Tribe and County where law enforcement services for Non-Natives are provided for on the property of Prairie Wind Casino, which is located in Oglala Lakota County, within the Exterior Boundaries of the Pine Ridge Indian Reservation, in Oglala South Dakota. The property includes but is not limited to: the Prairie Wind Casino, Hotel, Bingo Hall, various maintenance buildings, parking lot, and other future development on the said property.

#### GOAL

The County will assist the Tribe in providing the described services to the employees and patrons of the Tribally Owned enterprise located on the property, and subject to the limitations provided in this Memorandum of Agreement.

#### 3. LAW ENFORCEMENT SERVICES

The County agrees to provide law enforcement services to the extent, and in the manner, as follows:

A. The County will utilize the Prairie Wind Casino as an extra office area as needed, and as determined by the Oglala Lakota County Sheriff providing Law Enforcement Services as needed when it comes to Non-Native customers, as well as provide a visual sense of safety for all.

B. The provisions of services, the standards of performance, the discipline of the deputies, and other matters incident to the performance of such services, and the control of personnel so employed, shall remain under the control of the Oglala Lakota County.

C. It is agreed that the Sheriff of Oglala Lakota County shall have all reasonable and necessary cooperation and assistance from the Prairie Wind Casino, its officers, agents, and employees, so as to facilitate the performance of this Agreement.

- D. The Tribe, its officers and employees shall not be liable for the compensation or indemnification of the Sheriff, or any of his employees, for injuries or sickness arising out of their actions under this MOA. The County hereby agrees to hold harmless the Tribe, its officers, and employees against such claims, whether to person or property.
- E. The Tribe shall incur no liability for the intentional or negligent acts or omissions of the County, or its officers, agents, or employees in enforcing State Law over Non-Natives, or from actions by County personnel against persons sentenced or ordered to the custody of the State of South Dakota or the County.
- G. The Sheriff of the County will enforce State Laws only over Non-Native Americans on the property and will not have any jurisdiction over Tribal Members or any registered enrolled member of any Tribe. The Tribe may however allow the said officers to enforce Tribal Law.

#### 4. CONDITIONS

Nothing in this MOA shall expand or limit the legislative, regulatory, or adjudicatory jurisdiction of either party or the State of South Dakota. This MOA shall not be construed to and does not limit or otherwise affect either party's sovereign powers, including but not limited to either party's sovereign immunities.

#### 5. TERM AND PAYMENT

In consideration for the government services provided in this MOA, the Prairie Wind Casino agrees to provide as follows:

- Office Space at no charge, to include utilities, internet and a computer.
- The Oglala Lakota County Sheriff shall provide basic Law Enforcement services and provide a visual impact for all customers as determined by the Oglala Lakota County Sheriff.

This MOA shall be renewed annually with review.

#### 6. MEETING AND REPORT

The County shall meet annually with the Tribe and the Prairie Wind Casino to coordinate provisions of government services to the Tribe and the Prairie Wind Casino. The County and the Prairie Wind Casino shall provide an annual written report to the Tribe describing the County's provision of the requested services, which were provided during the previous year.

#### 7. PERFORMANCE

The parties agree to provide written notice of any situation or circumstance which inhibits the purpose or effect of this agreement to the Tribal Chairman or delegate, and the Chairman of the Oglala Lakota County Commissioners. Upon receipt of the written notice, the other party shall have 30 days to cure the alleged breach.

#### 8. SIGNATURES

in witness whereof, the parties to this MOU through their duly authorized representatives have executed this MOU on the days and dates set out below, and certify that they have read, understood, and agreed to the terms and conditions of this MOU as set forth herein.
