The Oglala Lakota Board of County Commissioners met in regular session on January 08, 2024. Present: Art Hopkins, Anna Takes the Shield (DuBray), Wendell Yellow Bull, Ramon Bear Runner and Sue Ganje, Auditor. Allyssa Comer was absent.

The meeting was called to order at 1:24 p.m. by Chairwoman Takes the Shield (DuBray). The agenda was reviewed for conflicts. ALL MOTIONS RECORDED IN THESE MINUTES WERE PASSED BY UNANIMOUS VOTE, UNLESS OTHERWISE STATED.

Chairwoman Takes the Shield (Dubray) presented Flags that were donated by the Oglala Sioux Tribe's Secretary's office to Veterans Art Hopkins, Wendell Yellow Bull, Lynx Bettelyoun, Sam White Face and Audrey Martinez.

Motion made by Yellow Bull, seconded by Bear Runner, to approve the agenda as written. The meeting was turned over to the Auditor.

The Auditor asked for nominations for the Chair. Motion made by Yellow Bull, seconded by Hopkins, to nominate Allyssa Comer as Chairwoman and Anna Takes the Shield (Dubray) as Vice-Chairwoman.

Motion made by Yellow Bull, seconded by Hopkins, to have nominations cease and cast a unanimous vote for Comer as Chairwoman and Anna Takes the Shield (Dubray) as Vice-Chairwoman for 2024.

The meeting was turned over to the Vice-Chairwoman.

Motion made by Yellow Bull, seconded by Hopkins, to approve the 1st Grouping of agenda items to include: Designate the bulletin boards for legal notices in Hot Springs, Pine Ridge Post Office and Tribal Building, Kyle Post Office and Kyle Clinic; to approve the First Interstate Bank, Black Hills Federal Credit Union and Schwab as the official depositories for the County in 2024; set the indigent burial rate at \$1,000.00 in 2024.

Motion made by Yellow Bull, seconded by Hopkins, to approve the 2nd Grouping of agenda items to include: Approve rate for prisoner housing in Fall River County at \$95.00 and \$120.00 per day and Pennington County at \$95.00 and \$120.00 per day in 2024; to not rehire any employee for a period of one year, if that employee has resigned and withdrawn their retirement funds, unless authorized by the Commission; Approve meeting the second Monday of every month, at 1:00 p.m.; Approve travel of the County Commissioners and Officials to attend Black Hills Association meetings and same day travel, and to require travel approval when an overnight stay is required.

Motion made by Yellow Bull, seconded by Hopkins, to approve the Sheriff Department fuel transfers for 12/19 through 12/28/2023 to reimburse the Highway Department for 16.2 gallons of gasoline at \$3.33 equaling \$53.946.

Motion made by Yellow Bull, seconded by Hopkins, to table the Banner Associates Contract until the next meeting due to questions regarding the mileage rate.

Motion made by Yellow Bull, seconded by Hopkins, to accept the Highway Department monthly report.

Jerlene Arredondo, Veteran Service Officer, met with the Board. A reminder was given regarding the motion made on December 28, 2023, by Bear Runner, seconded by Comer, to require all County employees to get permission from the Board prior to applying for or requesting funds from any outside sources. It was also noted that any employee of the County volunteering or providing services or support during their off-duty hours needs to expressly inform the public that they are not acting in their official capacity.

Motion made by Yellow Bull, seconded by Bear Runner, to table the requests from the Oglala Sioux Tribe for reimbursement until the next meeting on February 12, 2024 when the Treasurer of the OST will be invited to the meeting to answer questions on their request for reimbursement for meals provided at the Veterans Dinner at the Casino, and for tickets at the LNI.

Motion made by Yellow Bull, seconded by Hopkins, to accept the VSO monthly report.

Derek Puckett, Sheriff, submitted his letter of resignation due to wanting to keep his current fulltime employment as a School Resource Officer. There was discussion regarding the options for hiring a new Sheriff.

Wendell Yellow Bull, Commissioner, requested travel approval to attend the Lakota Construction Summit.

Motion made by Yellow Bull, seconded by Bear Runner to approve the travel request for Wendell Yellow Bull and Art Hopkins, to include Allyssa Comer if she desires to go at a cost of \$25.00 for Coalition Individual Member or \$50.00 for Individual Non-Member plus overnight accommodations.

Motion made by Bear Runner, seconded by Hopkins to request the Fall River County contracted departments to provide statistical information regarding the services provided for Oglala Lakota County residents to be brought back to the next meeting.

Dan Hudspeth met with the Board to offer his services to be appointed as County Sheriff until December 31, 2024. After discussion regarding his availability, the Board took no action.

Motion made by Bear Runner, seconded by Yellow Bull, to continue the appoint of Derek Puckett as County Sheriff until a permanent appointment can be made for the rest of 2024.

Motion made by Bear Runner, seconded by Hopkins, to appoint Jerlene Arredondo as the Oglala Lakota County Veteran Service Officer for a four-year period, effective January 2, 2024 through January 2, 2028.

Motion by Yellow Bull, seconded by Hopkins to approve the Lease Agreement between the Veteran's Shelter and the Oglala Lakota County Veteran Service Office.

Motion made by Yellow Bull, seconded by Hopkins, to table the MOA between Bauxsimone

Consulting, LLC, Behavior Management Systems, Inc and Oglala Lakota Housing Authority until the State's Attorney could research a few of the items included in the MOA and bring it back to the February 12, 2024 meeting.

Teresa Pullen, Treasurer, met with the Board to provide updates regarding the DANR's findings on certain properties that the county may acquire through the tax deed process in the Town of Batesland. Reference was made to SD-DENR # 86.050, a petroleum release site. If any petroleum oil is encountered on any property the county may acquire, the county will contact the DANR (previously known as DENR) and they will clean any issues.
