VSO Office Space Rental Agreement 2024

This Lease Agreement is by and between the Veterans Shelter, Oglala Lakota Housing Authority ("Leaser") and Oglala Lakota Veterans Service Office (Rm # 107), ("Lessee").

Purpose. The purpose of this lease is: Rent Office Space.

<u>Terms.</u> The lease shall commence on January 1, 2024, and terminate one year from that date. Lessee shall vacate the premises upon termination of the Lease Agreement unless: 1) The parties have agreed to an extension of the lease or signed a new lease Agreement; or 2) Leaser accepts payment other than past due rents and a month-to-month tenancy is created that can be terminated by 30 days written notice.

Rent. The monthly rate under this Lease Agreement is \$100.00 per month and is due on the first day of each month.

- 1. <u>Termination of Agreement.</u> The lease can be terminated by either party providing thirty (30) days written notice. The Leaser can terminate the lease for cause, including failure to pay rent, destruction of property and/or any criminal activity.
- 2. <u>Early Termination</u>. In the event of early termination, the Lessee shall pay \$100.00 or the remaining balance on the lease whichever is less.
- 3. <u>Utilities.</u> Electricity, heat, water, and sewer shall be included in the rent.
- 4. <u>Keys.</u> The Lessee will be provided with a set of keys to the office that shall be returned upon termination of the lease. If the keys are lost the Lessee will be charged \$20.00.

<u>Sublease</u>. The Lessee cannot sublease or assign the rental agreement to another party without the Leaser's written consent.

<u>Use.</u> The Lessee shall obey, and require anyone else on the premises, to obey all laws and restrictions that apply to the premises as well as tribal and federal laws that apply.
