OGLALA LAKOTA COUNTY UNAPPROVED MINUTES OF NOVEMBER 13, 2025

The Oglala Lakota Board of County Commissioners met in regular session at the Fall River County Courthouse, 3rd floor meeting room on November 13, 2025. Present: Allyssa Comer, Art Hopkins, Wendell Yellow Bull, and Sue Ganje, Auditor. Anna Takes the Shield (Dubray) was present via telephone. Ramon Bear Runner was absent.

The meeting was called to order at 1:06 p.m. by Chairwoman Comer. The agenda was reviewed for conflicts. ALL MOTIONS RECORDED IN THESE MINUTES WERE PASSED BY UNANIMOUS VOTE, UNLESS OTHERWISE STATED.

Motion made by Yellow Bull, seconded by Hopkins, to approve the agenda with the amendment to include discussion of the next meeting date.

Motion made by Yellow Bull, seconded by Hopkins, to approve the Commission meeting minutes of October 23, 2025.

Motion made by Hopkins, seconded by Yellow Bull to pledge one-third of the cost of the change of venue for the Uranium Chord Hearing to be in Hot Springs. Estimated amount for the county to be in the amount of \$1,956.67.

Motion made by Yellow Bull, seconded by Hopkins, to set the year end meeting to be on December 30th, 2025 at 1:30 p.m.

Motion made by Yellow Bull, seconded by Hopkins, to set the next meeting date to November 26^{th,} 2025, at 1:00 p.m. rather than on November 27th (Thanksgiving).

The Highway report was reviewed by Commissioners as the Highway Superintendent was attending the SD for the Safety Benefits Training in Pierre.

Discussion was held on creating a Foreman position in the Highway Department. Motion made by Yellow Bull, seconded by Hopkins to create the position, requiring 15 years' experience for the for a Highway Foreman position.

Bear Runner joined via phone at 1:26 p.m.

Motion made by Yellow Bull, seconded by Hopkins, to include a 90-day probation and to increase the starting wage for Highway Foreman by \$1.00 per hour.

Motion made by Yellow Bull, seconded by Takes the Shield, to approve fuel reimbursements from the Sheriff to the Highway Department for the Sheriff in the amount of \$69.65 and for the Deputy Sheriff in the amount of \$270.62

Sue Ganje, County Auditor, met with the Board and discussed Private Road work verbiage from "petition" to "Contract" A revised Mill Levy Resolution for taxes payable in 2026 was reviewed and signed by the commissioners.

Motion made by Yellow Bull, seconded by Hopkins, to table changing the verbiage from petition to contract on Highway Private Road work.

A discussion was held regarding potential employee appreciation pay.

Motion made by Takes the Shield, seconded by Bear Runner, to approve employee appreciation pay prior to Thanksgiving for November and prior to Christmas in December, 2025, in the amount of \$250.00 for Oglala Lakota employees.

Motion was amended by Takes the Shield, seconded by Bear Runner, to pay all employees of Oglala Lakota County \$500.00 in November and December and to also pay Fall River County contracted employees plus GIS and Emergency Management the amount of \$250.00 in November and December 2025.

Yellow Bull wanted to make it clear that this extra amount of money is strictly based on appreciating the employees that do services for Oglala Lakota County.

Teresa Pullen, County Treasurer, met with the Board to discuss updates on investments in Schwab and the cleanup of tax deeds. Pullen will bring updates regarding the investments to the next meeting.

Bear Runner left meeting at 1:57p.m.

At this time, a power outage caused the telephone systems to go down.

Takes the Shield called Comer and updated the Board on the Uranium Chord Project. She spoke with Taylor from NDN Collective on costs to move the Hearings to the City of Hot Springs plans on fund-raising to cover the portion that they were being asked to pledge. The fund raisers will be going on in the next couple weeks. Takes the Shield also asked for an itemized list of expenses from the state if the hearing is held in Hot Springs.

Motion made by Yellow Bull, seconded by Takes the Shield, to move a motion to pledge 1/3 of the cost of moving the Uranium Chord Project to a future meeting after there has been a determination of a final cost.

With the end of the year rapidly approaching, we would like to bring to your attention the matter of the state reimbursement for salary paid to your County Veterans Service Officer (CVSO).

SDCL 33A-1-30 and 33A-1-31 establish a reimbursement program for the Department to provide financial assistance for counties and tribes in paying a portion of the salaries of their CVSO's.

To reimburse you for CY 2025, we need a copy of the payroll ledger or individual earnings record for your veterans' service officer covering the period from January 1, 2025, through December 31, 2025. This document must be CERTIFIED by you, the County Auditor, as a true and factual statement of salary payments.

For future reimbursements starting in CY2026, your CVSO will be required to attend the SDDVA Annual Benefit School, one of SDDVA's mini conferences, host or participate in at least one veteran outreach event each quarter, and a new CVSO will participate in those mentioned above, as well as attend SDDVA's new VSO training program. Participation in these training opportunities ensures that your CVSO stays up to date with the ever-changing federal rules and regulations.

A signed copy of the agreement and the minutes of the commission meeting at which the agreement was adopted must be forwarded to SDDVA by February 1, 2026, to receive 2026 reimbursement.

MEMORANDUM OF UNDERSTANDING Between DAKOTA STATE UNIVERSITY and Oglala Lakota County

This MEMORANDUM OF UNDERSTANDING ("MOU") is entered into by and between the Dakota State University, Madison, South Dakota ("DSU") and Oglala Lakota County ("COUNTY"), a political subdivision of the State of South Dakota, on this 24th day of November 2025.

WHEREAS, during the 2024 South Dakota Legislative Session, Senate Bill 187 (SB 187) was enacted which appropriated \$7,000,000 to the Office of the Attorney General ("OAG") for the purpose of creating a cybersecurity initiative for counties and municipalities throughout the State of South Dakota; and

WHEREAS, DSU operates Madison Cyber Labs ("MadLabs"), which focuses on education, research, and cybersecurity development, including initiatives that help counties and municipalities mitigate cybersecurity risks; and

WHEREAS, DSU, in partnership with the OAG, created the SecureSD Cybersecurity for Counties and municipalities to strengthen cybersecurity resilience among counties and municipalities in South Dakota; and

WHEREAS, DSU, in partnership with the OAG, seeks to protect and enhance the cybersecurity posture of South Dakota's counties and municipalities by leveraging SecureSD resources effectively; and

WHEREAS, COUNTY acknowledges the importance of cybersecurity mitigation and agrees to participate in SecureSD by providing the necessary cooperation, engagement, and local implementation efforts required to enhance security.

NOW THEREFORE, in consideration of the covenants and agreements contained herein, and the joint and mutual responsibilities flowing to each party as outlined in this Memorandum of Understanding, the parties agree:

1. PURPOSE

This Memorandum of Understanding (MOU) is undertaken by and between DSU and COUNTY to protect and enhance the cybersecurity posture of South Dakota's counties and municipalities through the SecureSD Program. SecureSD is designed to support counties and municipalities by providing technical mitigation assistance to reduce cybersecurity risks, delivering training and awareness programs for municipal and county staff, and enhancing cybersecurity resilience through the implementation of best practices and security tools through a secure email system.

2. FUNDING

- A. SecureSD is funded by the appropriation established by SB 187 during the 2024 legislative session. The COUNTY acknowledges that SecureSD does not provide direct financial payments for cybersecurity efforts, nor does SecureSD offer direct financial aid. As such, no direct financial payments will be made to COUNTY under this MOU.
- B. Nothing in the MOU may be construed as, or may be relied on, as a future promise or commitment to providing any future funding, services, or support.

3. DSU RESPONSIBILITIES

- A. Implementation of SecureSD
 - 1. Oversee and implement cybersecurity mitigation and email strategies for counties or municipalities.
 - 2. Engage with managed service providers ("MSPs") to determine appropriate scopes of work, perform work, and/or review work as needed, based on DSU's recommendation.
 - 3. Deploy technical resources to support and enhance cybersecurity defenses.
 - 4. Provide cybersecurity education and training for municipalities and counties on an as needed basis in the sole discretion of DSU.
- B. Compliance and Reporting
 - 1. Maintain records showing:
 - a. The counties and municipalities participating or planning to participate in this initiative.
 - b. Completed and planned cybersecurity improvements for each participating local government.
 - c. Current and expected expenses for each improvement, including the cost related to SB 187.
 - d. Expected timeframes for completing the improvements.
 - e. Monthly reports including activities conducted, detailed financial information, and all information necessary to justify approval of vouchers submitted for payment.
 - 2. Provide all necessary updates and reports to the OAG and request all necessary prior authorizations according to the tenor of the agreement between DSU and the OAG dated August 26, 2024.

4. RESPONSIBILITIES OF COUNTY

- A. COUNTY agrees to obtain a security assessment either through Project Boundary Fence or through a private vendor which is at least as technically comprehensive as the assessment conducted through Project Boundary Fence.
- B. Engagement and Participation
 - 1. Actively participate in SecureSD initiatives, including mitigation activities and training.

- 2. Designate a single point of contact for communication between COUNTY, DSU, and the OAG.
- C. Implementation, Maintenance, and Ownership
 - 1. Actively participate with selected MSP and DSU to facilitate implementation of cybersecurity measures set forth in the scope of work approved by DSU and COUNTY.
 - 2. Provide reasonable cyber and physical access to city/county/municipality facilities to the selected MSP and DSU personnel to implement the approved cybersecurity measures and to DSU upon completion to ensure the scope of work was properly implemented and in good working order.
 - 3. Provide reasonable access to OAG for oversight purposes to ensure that any hardware purchased pursuant to the scope of work, if any, is implemented and in use.
 - 4. COUNTY is aware and understands:
 - a. The funds appropriated pursuant to SB 187 of 2024 are one-time funds.
 - b. As such, any hardware, licenses, or software purchased or implemented as part of the scope of work becomes the sole property of the county/municipality and the MSP, DSU, and the OAG has no ongoing responsibility for any further improvements, ongoing licensing, maintenance, or upkeep of the installed improvements.
 - c. There is no expectation, promise, or guarantee of any future funding to address cybersecurity risks through SecureSD or otherwise.
 - d. SecureSD does not and will not provide any direct financial compensation, reimbursements, or direct payments of any kind to the COUNTY.

5. <u>MISCELLANEOUS PROVISIONS</u>

- A. Confidentiality
 - 1. DSU hereby acknowledges that any and all technical details including access information, technical data, and any personally identifiable information ("PII") housed on or accessible through the COUNTY systems is deemed "Confidential Information" and may not be shared among or between any other participant in this initiative, or to any third party except the selected MSP and the OAG as may be required.
 - 2. DSU will limit access to COUNTY cybersecurity data to authorized personnel only.
- B. Effective Period, Modification, and Termination
 - 1. Effective Period of MOU: This MOU shall become effective upon the date last signed below. This MOU shall remain in effect until 6/30/28 unless sooner terminated pursuant to the terms set forth herein.

- 2. Modification of MOU: This MOU may not be amended except in writing, which writing shall be expressly identified as a part hereof and be signed by an authorized representative of each of the parties hereto.
- 3. Termination of MOU: Either party may terminate this MOU upon thirty (30) days written notice. The termination shall be effective thirty (30) calendar days from the date of such notice, or at a later date agreed upon by the parties, so long as such date does not exceed the date of termination of this MOU.

- D. Joint Powers

This MOU is not a Joint Powers Agreement or cooperative action agreement pursuant to SDCL Ch. 1-24, and it does not establish a separate legal entity under SDCL 1-24-4(2) or create a joint administrator or governing board, as contemplated by SDCL 1-24-5. Each party has responsibilities under the terms of this Agreement and no joint board or administrator will be used.

E. Governing Law and Venue

This MOU shall be governed by and construed in accordance with the laws of the State of South Dakota, without regard to any conflicts of law principles, decisional law, or statutory provision which would require or permit the application of another jurisdiction's substantive law. Venue for any lawsuit pertaining to or affecting this Agreement shall be in the Circuit Court, Sixth Judicial Circuit, Hughes County, South Dakota.

F. Limitation Of Liability

In no event shall any party be liable to another party for any indirect, incidental, consequential, special, punitive, exemplary, or extra-contractual damages of any kind whatsoever arising from or connected with this MOU, including, but not limited to, lost profits, lost revenues, or loss of business, regardless of legal theory, whether or not foreseeable, even if either party has been advised of the possibility or probability of such damages and even if the remedies otherwise provided by this agreement fail of their essential purpose.

OGLALA LAKOTA COUNTY COMMISSION RESOLUTION NUMBER _____

A RESOLUTION, In support of revoking the Medals of Honor given to the United States soldiers who participated in the Wounded Knee Massacre of 1890.

WHEREAS, the United States' highest honor for valor is the Medal of Honor, and Congress established that, in order to obtain the Medal of Honor, the deed of the person must be so outstanding that it clearly distinguishes the soldier's gallantry beyond the call of duty from lesser forms of bravery; and

WHEREAS, allowing honor to the Seventh Calvary for acts in the Wounded Knee Massacre dishonors the Medal of Honor and is an implication of hostility and genocide against the Great Sioux Nation and the persons who were killed by the United States at Wounded Knee; and

WHEREAS, Chief Big Foot and his band were impeded by Major Whiteside on the Pine Ridge Indian Reservation at Porcupine Butte, where surrender took place unconditionally under a white flag of truce, causing Chief Big Foot and his band to be led to Wounded Knee Creek, where Colonel James W. Forsyth assumed command; and

WHEREAS, the Seventh Calvary stripped the Lakotas of all belongings and disarmed them of weapons of any kind; a shot was then heard, and the calvary opened fire indiscriminately while discharging Hotchkiss cannons, resulting in the killing and wounding of no less than three hundred unarmed men, women, children, and elderly Lakotas; and

WHEREAS, the Seventh Calvary was recognized to have killed a sizeable number of women and children by Major General Nelson Miles who said, "[w]holesale massacre occurred and I have never heard of a more brutal, cold-blooded massacre than that at Wounded Knee;" and

WHEREAS, Lakota Holy Man, Black Elk, described Wounded Knee as follows, "I did not know then how much was ended. When I look back now from this high hill of my old age, I can still see the butchered women and children lying heaped and scattered all along the crooked gulch as plain as when I saw them with eyes still young. And I can see that something else died there in the bloody mud and was buried in the blizzard. A people's dream died there. It was a beautiful dream. And I, to whom so great a vision was given in my

youth, you see now a pitiful old man who has done nothing, for the nation's hoop is broken and scattered. There is no center any longer, and the sacred tree is dead;" and

WHEREAS, Medal of Honor recipients are under an obligation, through their actions, to exemplify courage to those who are serving in the Armed Forces and to those who are planning to serve; and

WHEREAS, to date, the Medal of Honor has been bestowed only three thousand five hundred twenty-two times, including one hundred twenty-six instances for World War I, one hundred forty-five instances for the Korean War, twenty-three instances throughout the Global War on Terror, and twenty times for the Wounded Knee Massacre; and

WHEREAS, no action has been taken at the federal level to correct this injustice.

NOW, THEREFORE, BE IT RESOLVED, by the Oglala Lakota County Commission, that the Commission hereby requests that efforts be made to investigate each Medal of Honor awarded to the United States Army members who acted at Wounded Knee Creek, Pine Ridge Agency, South Dakota on December 29, 1890; and

BE IT FURTHER RESOLVED, that the Oglala Lakota County Commission requests support in this effort from Senators John Thune and Mike Rounds and Representative Dusty Johnson, with support from President Trump, the Commander in Chief, to do so; and

BE IT FURTHER RESOLVED, that it is requested that upon congressional passage the name of each person awarded the Medal of Honor for the acts noted above be removed from the Medal of Honor Roll enabled under section 1134a of title 10 of the United States Code.
