The Oglala Lakota Board of County Commissioners met in regular session at the Fall River County Courthouse, 3rd floor meeting room on December 30, 2025. Present: Art Hopkins, Wendell Yellow Bull, and Sue Ganje, Auditor. Allyssa Comer Via Telephone. Anna Takes the Shield (Dubray) and Ramon Bear Runner were absent.
