The Oglala Lakota Board of County Commissioners met in special session at the Fall River County Courthouse on April 2nd, 2026. Allyssa Comer, Art Hopkins, Ramon Bear Runner and Sue Ganje, County Auditor, Anna Takes the Shield, and Wendell Yellow Bull were absent.

The meeting was called to order at 1.23 p.m. by Chairwoman Comer. The agenda was reviewed for conflicts. ALL MOTIONS RECORDED IN THESE MINUTES WERE PASSED BY UNANIMOUS VOTE, UNLESS OTHERWISE STATED.

Dar Coy, Oglala Lakota, Emergency Management discussed interest in a Hazmat Emergency Response plan. Runner suggested Coy work with Steve Wilson Oglala Sioux Tribe Emergency Management. If interested, the board will hire Black Hills Council of Local Government, Jennifer Sietsma. Cost \$7500.00, Federal Grant for five-year plan. The Federal Government will pay \$6000.00. Final Co-Pay will be \$1500.00.

A RESOLUTION AUTHORIZING THE PURCHASE OF REAL PROPERTY FOR THE OGLALA LAKOTA COUNTY HIGHWAY DEPARTMENT SHOP AND BUILDING; AUTHORIZING THE EXPENDITURE OF FUNDS FOR THE PURCHASE OF THE REAL PROPERTY; AND AUTHORIZING THE DOCUMENTS TO EFFECTUATE THE TERMS AND INTENT OF THIS RESOLUTION.

BE IT RESOLVED by the Oglala Lakota County Board of Commissioners (the "County of Oglala Lakota"), as follows:

WHEREAS, the County of Oglala Lakota is authorized to acquire real property pursuant to South Dakota Codified Law 7-8-20(5), and

WHEREAS, the County of Oglala Lakota has determined that in order to acquire desirable land for the Oglala Lakota County Highway Department Shop and Building, it is necessary and desirable to acquire the real property, including the buildings and improvements thereon, however, excepting the grain bins, and described as Lynx Tract, located in the E1/2 of the NE1/4 of Section 3, Township 35 North, Range 43 West of the 6th Principal Meridian, Oglala Lakota County, South Dakota; and

WHEREAS, the real property described herein is being acquired by the County of Oglala Lakota and will be utilized and operated by the Oglala Lakota County Highway Department
